We would like to take this opportunity to thank Ros Matty who stood down as our Patron in January 2019.


Ros spent over 18 years working within Hospice at Home in South Essex. Fair Havens Hospice @ Home was launched in 1992, one of the first in the country with Ros in charge and this also coincided with her developing the then National Forum for Hospice at Home bringing together like minded services providing specialist End of Life Care to patients at home under one umbrella.

She was also instrumental in setting up the first Annual Conference which still continues to this day. Her drive and determination has resulted in a huge legacy not just locally in Essex but nationally during her time with the Association.

Ros was the NAHH Secretary from 2000 - 2008 and some of those basic tenets she brought to the new membership organisation are still relevant now and indeed form part of the Associations' core ethos to this day.

We wish her all the best in her well-earned retirement. As she recently commented "My abiding memory will always be that of the huge privilege that it is to support dying patients and their families at home so that they could die peacefully where they most wanted to be".

Rosalind Matty former NAHH Patron 2000 - 2019



"As I was standing down from being patron of the NAHH I was asked if I would share a hi-light or an anecdote from my memories of Hospice at Home in South Essex, having worked for 18 years with two local hospices to provide 'hospice at home' care and support for literally thousands of patients and their families.

My abiding memory will always be that of the huge privilege that it is to support dying patients and their families at home so that they could die peacefully where they most wanted to be."

An Unusual Situation

I vividly remember an unusual new patient referral one very snowy evening when I was the Hospice at Home co-ordinator on-call. It was for an elderly lady in her mid-70s who had never been in hospital before in her life but who had suddenly become very poorly, and it rapidly became evident that she had been ignoring symptoms that she'd had for some time.

She had been admitted to Rochford Hospital the previous day and I received a phone call at about 9.00pm that evening from her distraught son who said, "My mum is riddled with cancer. She's only been in hospital 48 hours, but she's dying and I don't want her to be here. She never wanted to be in hospital. I want her to come home." He was the nephew of one of the District Nurses whom I knew well. I phoned the District Night Sisters and explained the situation to them.

Jackie, who was the District Night Sister on duty, and one of my colleagues when I too had worked as a District Night Sister, suggested that we go and see the lady in hospital to see if there was anything that we could realistically do. We went to Rochford Hospital together and met and talked with the son. We told him we couldn't make any promises, but we'd see what we could do to help. The Ward Manager was very empathetic with the son, and explained to us that the patient lived in sheltered accommodation, and that we would need to speak to the warden to get her back in to her home. She was very drowsy and we knew that she was not far from death.

With the support of the Ward Manager, Jackie and I spoke to the son, saying, "We can arrange this, if it is really what you want for your mum, but you need to appreciate that moving her might be too much for her, and she might die in the ambulance." He needed some space to think about it, so left us with his mum. He came back after half an hour, saying, "I can't handle the thought of my mum dying in an ambulance. That would be dreadful, but I think I can accept that she will be well looked after here as long as I can be with her." So we left him sitting with his mum, much more at peace with himself than when we'd first arrived on the ward.

He rang to tell me that she had died at 2.00pm the next day. It was his mum's perceived loss of dignity and choice that he hadn't been able to cope with, but he was grateful that Hospice at Home had listened to him and given him the choice, which was what he needed to enable him to make the right decision for his mum.

Dame Cicely Saunders, the founder of the hospice movement, once said, "How people die lives on in the memories of those who live on."
